


Insulation performance curve chart (30°C Thermos cup + 2 ice strips)




Insulation performance curve chart (30°C Thermos cup + 4 ice strips)






Insulation performance curve chart (30° Thermos cup + 8 ice strips)




Insulation performance curve chart (30°C Thermos cup + 10 ice strips)








Insulation performance curve chart  $(35^{\circ})$  Thermos cup + 6 ice strips)


Insulation performance curve chart  $(35^{\circ})$  Thermos cup + 8 ice strips)








Insulation performance curve chart (40°C Thermos cup + 2 ice strips)




Insulation performance curve chart  $(40^{\circ})$  Thermos cup + 4 ice strips)





Insulation performance curve chart (40°C Thermos cup + 6 ice strips)
